XI. BOARD RESOLUTIONS

1. MOA - TTA Retirement Incentive (Addendum VI)

BE IT RESOLVED, that the Board of Education of the Enlarged City School District of Troy, NY hereby approves a Memorandum of Agreement between the District and Troy Teachers Association for a special one-time retirement incentive for retirements effective June 30, 2014 only.

2. MOA - CSEA Retirement Incentive (Addendum VII)

BE IT RESOLVED, that the Board of Education of the Enlarged City School District of Troy, NY hereby approves a Memorandum of Agreement between the District and Civil Service Employees Association for a special one-time retirement incentive for retirements effective June 30, 2014 only.

3. Management/Confidential Employees Retirement Incentive

BE IT RESOLVED, that the Board of Education of the Enlarged City School District of Troy, upon the recommendation of the Interim Superintendent, hereby approves a special one-time retirement incentive for management/confidential employees for retirements effective December 31, 2014 only.

- a. In order to qualify for this special incentive:
 1. an employee must be 55 years of age or older as of June 30, 2014;
 2. said employee must have at least ten (10) years of consecutive service with the District as of the date of retirement; and
 3. an irrevocable letter of retirement must be provided to the District Business Office by 2:00 p.m. on February 24, 2014.
- b. Eligible management/confidential employees shall be entitled to a retirement incentive of \$7,500.
- c. The incentive referred to at Paragraph (b) above shall be paid within thirty (30) days after the effective date of retirement.

4. Call to Reduce Over-Reliance on Standardized Tests

WHEREAS, every student deserves a quality public education dedicated to preparing engaged citizens, creative and critical thinkers and lifelong learners ready for college and careers; and WHEREAS, the decline in state aid and support for public schools has forced our district to reduce programs and limited our ability to fully implement new programs mandated by the state such as the common core standards thereby creating an uneven rollout of the standards among school districts around the state; and

WHEREAS, while the implementation of the common core standards will ultimately help students, teachers and the teaching and learning process, the growing reliance on, and misalignment of standardized testing is eroding student learning time, narrowing the curriculum and jeopardizing the rich, meaningful education our students need and deserve; and

WHEREAS, despite the fact that research recommends the use of multiple measures to gauge student performance and teacher effectiveness, the state's growing reliance on standardized testing is adversely affecting students across all spectrums and the morale of our educators and is further draining already scarce resources; and

WHEREAS, the federal elementary and secondary education act's testing policies fail to appropriately accommodate the unique needs of students with disabilities and English language learners in assessing their learning, resulting in test scores that do not accurately represent a true measure of contributions of teachers and schools; and
WHEREAS, it is time for policymakers to recalibrate the number, duration and appropriate use of standardized tests so we can refocus our efforts on student learning; now, therefore, be it
RESOLVED, that we call upon the Commissioner of Education, the NYS Board of Regents and other policymakers to reduce the use of and over-reliance on standardized testing; and, be it further
RESOLVED, that we call upon the U.S. Congress and the Administration to reduce federal testing mandates and support the role of and focus on multiple measures of student learning and school quality in accountability systems.

5. 2013-14 School Safety Plans

BE IT RESOLVED, that the Board of Education of the Enlarged City School District of Troy, NY, hereby accepts the recommendation of the Superintendent to approve the confidential district and building Safety Plans for the 2013-14 school year.

6. Clerk of the Works (amendment to BOE 12-4-13)

WHEREAS, on April 13, 2011, the Board appointed Robert VanAuken as Clerk of the Works, at an annual rate of \$62,400, to provide services to the Enlarged City School District of Troy in connection with the Capital Project involving reconstruction of Troy Middle School and upgrade of the District's athletic fields; and

WHEREAS, the District requires the services of the Clerk of the Works through January 31, 2014 to assist the District with the preparation and completion of the 'punch list' of incomplete and/or corrective work relating to the Capital Project and/or to assist the District with the close-out of the construction contracts relating to the Capital Project; and

WHEREAS, in the event the services of the Clerk of the Works are required beyond January 31, 2014, the District may extend his employment for an additional period not to exceed 30 days at a per diem rate of 1/260th of his annual salary.

NOW, THEREFORE, BE IT RESOLVED that the Board of Education of the Enlarged City School District of Troy continue the provisional appointment of Robert VanAuken as Clerk of the Works, at an annual rate of \$62,400, through January 31, 2014, in order to assist the District with 'punch list' and/or close-out activities relating to the Capital Project, with the Clerk of the Works reporting directly to the Superintendent of Schools; and

BE IT FURTHER RESOLVED that such appointment may be extended beyond January 31, 2014 for an additional period not to exceed 30 days, if, in the judgment of the Superintendent of Schools, the services of the Clerk of the Works are required in order to complete said 'punch list' and/or close-out activities, and, in such case, the Clerk of the Works shall be paid at the per diem rate of 1/260th of his annual salary.
