IV. RETIREES RECEPTION

At 6:00 pm the Board of Education hosted a reception in the Troy Room for 2014 retirees. Mr. Schofield and Mr. Carmello presented each employee with a certificate of recognition and a gift.

At 7:00 pm Mr. Schofield called the Public Session to order with the Pledge of Allegiance. Mr. Schofield welcomed new board member Mary Marro-Giroux.

VII. SUPERINTENDENT'S REPORT - J. CARMELLO

<u>Presentation to Softball Team</u> - Mr. Carmello said he is very proud of the THS Girls Softball Team and recognized them as Big 10 Champions; Section II Champions and Regional Champions. Coach George Rafferty said the team has worked hard for two years; the girls have a great work ethic and are good students. Coach Rafferty is happy to be in their lives and they have made big impact on his life.

VIII. TREASURER'S REPORT - K. CIETEK

May Financials - District Treasurer Kathleen Cietek reported on May financials sent to the Board on Friday. Budget transfers for May are salary-related and to close out year-end expenses. More transfers will occur in June as we complete this process. The Internal Claims Auditor reviewed 368 payments for May totaling approximately \$1.8 million.

<u>General Fund</u> - We anticipate using approximately \$372,000 of the fund balance. We are in the process of closing out the current year. The preliminary audit was completed one day early. <u>School Lunch Fund</u> - we anticipate an excess in revenue over expenditures of \$173,990. As noted in the report, we have a positive fund balance. <u>Special Aid Fund</u> - A request for funds has been made to SED for each special aid fund whose expenditures exceeded their revenue. We are starting the close-out process for the grants and by June 30th all revenues and expenses will be equal.

<u>Treasurer's Report</u> - All accounts have been reconciled. There are no cash flow issues and we are in the process of reviewing next year's cash flow.

VIII. POLICY REVIEW - J. CARMELLO

Mr. Carmello reported on the following policies reviewed by the Policy Committee on May 27th and the school attorney. Three policies were approved recently; however, NYSSBA recommended additional language. Three policies are recommended for abolishment because they are already stated in the regulation.

<u>Discussion</u> - Mr. Tuttman asked about Policy 5420 and if it was necessary to receive parent consent for sunscreen as stated. Ms. Ahearn said due to allergy risk and touching students for application, prior permission is required.
