# B. Treasurer's Report - S. Conyers

1. May Financials

District Treasurer, Sarah Conyers, reported on May financials. Most budget transfers were salary related. Internal Claims Auditor reviewed 562 claims totalling approximately \$4.6 million. We are projecting \$1 million surplus in the General Fund. The botton line has been re-adjusted to show math for portion to be appropriated to the capital project. We are still under 4% cap for unassigned fund balance.

School Lunch projections remain the same. Special Aid - All grants are approved. Grants Office is working with Technology for the purchase of equipment for Learning Technology grant. Treasurers Report - All accounts have been reconciled. There were no questions.
