III. EXECUTIVE SESSION

At 6:56 pm Mr. Mayo made a motion to enter into Executive Session for a contractual matter.

IV. MOVE TO PUBLIC MEETING

At 7:05 pm the Board resumed the public meeting.

V. SAFETY PLAN HEARING

Public Hearing on District's Safety Plan was held in accordance with NYSED requirements and for protection of our students. Superintendent Atiba-Weza reported that each building has a safety plan to allow our schools to stage an emergency if one occurred; final plan from principals will be forwarded to state police. Plan is not a public document because it could violate safety of students. VADIR reports are also filed but we have not had any major safety issues. District is certain students and staff are safe due to proper planning. The Superintendent recommended the District hire a Coordinator of Safety. There were no comments from the public.

VI. SUPERINTENDENT'S REPORT

Dr. Atiba-Weza congratulated high school students honored at reception this evening. Graduation rate is 75 percent but we need to strive for higher goals by building a foundation which begins in elementary school. District is waiting for SED report regarding improvement for the Middle School. Mr. Carmello will lead a team for Capital Area School Development Association to raise the bar for middle school and high school student achievement levels.

(1) Stacey Sadowski (parent) - thanked BOE for reception for THS students. Congratulated Mr. Carmello, Mr. Mariano and Cara Salvi. We need a director for safety and please keep officers in our schools.

(2) Ebi Campbell (teacher assistant) - Thanked BOE and staff for supporting art program at School 1. We will write grants and continue with program next year.

(3) Marge Davey (CSEA President) - Congratulated Mr. Carmello and Mr. Mariano. Board recently discussed outsourcing Business Office to save money; how is HR Director salary increase financially responsible?

(4) Mark Walsh (TTA President) - Congratulations to tenure appointments and Mr. Carmello and Mr. Mariano on their promotions. We need to change suspension procedures;

(5) Rita Hotaling (teacher) - Teachers represented the District in recent "Relay for Life" and raised over \$3,300 for cancer.

Mrs. Harvin stated that this is Dr. Atiba-Weza's last Board meeting. The Superintendent has worked hard and has had to make difficult decisions. She wished him the best in the future.
