MINUTES

MEETING CALLED TO ORDER

III. EXECUTIVE SESSION

At 6:01 pm Mrs. Wager-Rounds made a motion to move to Executive Session to discuss a pending litigation and personnel issues. The motion was seconded by Mr. Mayo and carried 8-0. Mrs. Harvin arrived at 6:30 pm. Also invited in were Dr. Howard, Mr. Carmello, Ms. O'Neill, Ms. Miaski and Mrs. O-Grady-Parent.

IV. DISTRICT COMMUNITY ANNOUNCEMENTS

Mrs. Wager-Rounds recognized District Spelling Bee winners: 1st place Kiona Murray from School 2. Runners up were Kyla McFadden (CHS) and Carter Washock (PS16). Kiona and Carter were presented with a certificate. All 3 qualify for Regional Spelling Bee in March.

VI. CAPITAL PROJECT UPDATE

Marc Rivers of U.W. Marx and Kersten Lorcher of Mosaic Associates gave a monthly update on the Capital Project. Most areas are ready for painting including the large gym, cafeteria and hallways. Nora McDowell, PS14 parent, suggested a sidewalk along the baseball fields to School 14 for safety reasons. Mr. Marx indicated that is not part of the Capital Project plans and this is not in the budget. The Capital Project remains within budget and on schedule for completion.

VII. SUPERINTENDENT'S REPORT

Recommendation of Building Use Committee

- Dr. Howard presented the following recommendations of the Building Use Committee for discussion:
- (1) School 12 should be used to house Central Administration, Alternative Learning Program and PreK classes:
- (2) School 1 should be sold, rented or leased to an appropriate educational institution and/or non-profit organization. If tenants are not found, School 1 should be placed on the market but will have to be maintained; and
- (3) Zak House should be razed and if funds are available (Capital Project) the area should then be paved for additional parking for School 14.

The committee had suggestions that will need additional research: (1) create a pilot early childhood program by adding 2 to 3 kindergarten classes in School 12. We need to research if those students would receive the same extensions they would if in an elementary building. Students would be walkers from the area around School 12; and (2) relocated Special Education/Pupil Services to a school building (i.e. TMS, THS or PS2). There is space at School 12 for a possible career academy program.

It was Dr. Howard's recommendation (not the committee's) to take the next 12-18 months to look at certain bulges in the buildings and conduct a comprehensive study of distribution of students in the District. When completed, use the information to modify the school attendance zones to redistrict the students so they are distributed evenly and more equitably. This will take time to analyze. He thanked the Building Use Committee for their time and recommendations.

Discussion:

Mrs. Wager-Rounds requested the BOE see a floor plan for PS12 before they make this decision. She thanked the Committee on behalf of the Board.

Mr. Tuttman would like us to talk with government agencies about the disposal of PS1. He asked for the cost to raze the Zak House. It would be approximately \$30,000.

Mrs. Harvin stated that if we cannot sell School 1, we should lease it. However, she does not want it to be purchased by RPI. She would be in favor of re-districting again. We should take our time and look at teacher-student ratios. Mrs. Harvin thanked the Committee.

VIII. PUBLIC INPUT ON AGENDA AND NON-AGENDA ITEMS

(1) Bill Sherman (Director of Operations for Troy Prep Charter School) - He has been attending BOE meetings since last year. He would like to continue to learn about Troy Schools. He would like to meet with and potentially partner with the District to further student achievement in Troy. At the last workshop meeting there were some misconceptions stated about charters schools that he would like to clarify:

Troy Prep student demographics: 92.7% qualify for free or reduced lunch; 73% are black or Hispanic; 52% are white. Troy Prep students pull from 10 districts. 77% are from Troy School District; 14% from Lansingburgh. Current enrollment is 328. There is an open lottery as required by law.

- (2) Nora McDowell (PS14 Parent) School 14 is a high needs school. She appreciates the breakfast program and bussing to after school programs. Good things are happening in the District. We need to learn from other schools of the importance of marketing and outreach to the community. Teachers, principals and students are working hard but public at large does not know this.
- (3) Mark Walsh (TTA President) Thanked Dr. Howard, his peers and Building Use Committee for their time. The push is to keep PS12's programs flexible for long-term planning. He welcomed new faculty to the district. CSEA incentive would be good for the budget.

Mr. Tuttman asked about the High School musical. It will be held at Lansingburgh High School on April 25-26.
